FOUNDATION & OBJECTS.

THE ROYAL SOCIETIES CLUB was founded in the year One Thousand Eight Hundred and Ninety-four for the association in membership of Fellows and Members of the principal Royal and Learned Societies of the United Kingdom, India and the Colonies; Academicians and Associates of the Royal Academies; Professors, Fellows and Graduates of the Universities; and Presidents, Members of Council, Professors, Fellows, and Members of the various Literary, Scientific, and Art Institutions.

Members of Foreign Learned Societies, Academies, and Institutions of recognised *status* are eligible as Extraordinary Members. The privileges and liabilities of Extraordinary Members in all respects correspond with those of Ordinary Members.

RE-UNIONS.

EXTENSIVE alterations and additions have recently been made to the premises, to meet the requirements of the increasing membership, and the large

attendances at Banquets, Lectures and Re-unions, which are a specially attractive feature ; and the Club-house is now one of the most modern and refined in St. James's.
