## DEATH OF H. M. THE KING.

His Majesty King EDWARD VII, Doctor of Civil Law, Christ Church, Visitor of University College, Oriel College, and of Christ Church, died at Buckingham Palace on Friday, May 6, 1910, at 11.45 P.M., in the Sixty-ninth year of His Age and Tenth of His Reign.

In reply to a message sent on behalf of the University on Saturday morning, May 7, the Vice-Chancellor received the following Telegram:—

"BUCKINGHAM PALACE.

The Queen sends you her sincere thanks for your kind expression of sympathy.

## I. University Acts.

I. CONVOCATION.

Proclamation of His Gracious Majesty King George the Fifth.

In a CONVOCATION holden in the Divinity School on Tuesday, May 10, at Twelve o'clock—

The SENIOR PROCTOR recited the official Document from the Privy Council, being the Warrant for Proclaiming HIS MAJESTY.

Mr. VICE-CHANCELLOR recited the Proclamation.

The first verse of the National Anthem was sung.

Mr. VICE-CHANCELLOR gave the signal for acclamation at the accession of KING GEORGE.

Note .- At the conclusion of Convocation, Mr. Vice-Chancellor, followed by the Doctors, Proctors, and Members of Convocation, in due rank and order, proceeded through the great door opposite Hertford College, down the street past the Radcliffe Camera, and entered St. Mary's Church by the north door, reaching the Church about a Quarter-past The Persons forming the Procession waited in Twelve. the Church till the City Authorities began to move, and then passed through by the south-east door to a platform erected in the churchyard. Shortly after, the Mayor, Aldermen and Sheriff of the City came on foot, and stopped immediately before the spot where the Vice-Chancellor and Proctors were stationed, who, together with all the members of the University, remained uncovered, while the Town Clerk read the Proclamation. All having joined in acclamation at the accession of King George, and the Vice-Chancellor and Mayor having exchanged greeting, the City Procession moved on, and the members of the University retired through St. Mary's Church, the bells ringing, and the Organist playing "God Save the King."

The Warrant and the Proclamation were issued as Supplements to the last GAZETTE.

## III. CONVOCATION.

In a CONVOCATION holden on Tuesday, May 10, the following business was submitted to the House:—

## 1. Honorary Degree.

It was resolved (*nemine contradicente*) to confer the Degree of D.Sc., *honoris causa*, upon EMILE CAR-TAILHAC, Correspondent of the Institute of France, Lecturer on Prehistoric Archæology in the University of Toulouse, Keeper of the Natural History Museum, Toulouse, Commissioner for Preservation of Prehistoric Monuments under the Ministry of Public Instruction and Fine Arts.

## 2. Approval of Delegate for the Training of Elementary Teachers.

The name of HENRY T. GERRANS, M.A., Fellow of Worcester College, who had been duly re-nominated by the Vice-Chancellor and Proctors as a Delegate for the Training of Elementary Teachers, was submitted to the House and approved (*nemine contradicente*).

## 3. Voting on Statutes.

The following forms of Statute, which were approved by Congregation on Tuesday, May 3, were submitted to the House and approved (*nemine contra-dicente*) :--

## (1)

WHEREAS it is expedient that a Fund should be established for the provision of instruction in English, and that the administration of such Fund should be regulated by Statute, THE UNIVERSITY ENACTS AS FOLLOWS.

1. In Statt. Tit. V, after Sect. VIII (p. 130, ed. 1909), the following new Sectio shall be inserted :--

## "SECTIO IX.-CONCERNING THE ENGLISH FUND AND THE MANAGEMENT THEREOF.

1. There shall be a Fund, which shall be styled the English Fund, and shall be applied to the provision of instruction in the English Language or in English Literature or in both.

2. The English Fund shall be administered by the Board of Studies for the Examination in the Honour School of English Language and Literature.

3. The Board of Studies shall have power to appoint lecturers in English and to pay them, to fix and to receive fees payable by those attending their lectures, and to receive such sums as by arrangement with the Colleges may be entrusted to them for the tuition of students, and also to receive sums otherwise contributed to the Fund for the promotion of the study and teaching of English. Any lecturer appointed under the provisions of this clause shall receive at the time of his appointment a written statement of the conditions, emoluments, and duration of his office, and notice of his appointment shall be published in the usual manner. The appointment of a lecturer, other than an occasional lecturer, his emoluments, and the conditions of his office, including the fees payable for attendance at his lectures, shall in every case be subject to the approval of Convocation.

4. The Board of Studies shall also have power to apply to the provision of occasional lectures or courses of lectures any surplus in the Fund remaining after the payment of lecturers under the provisions of clause 3 above.

5. No fee shall be required in respect of attendance at any of the lectures provided by the Board of Studies from any student for whom there shall have been paid to the Board of Studies, by himself or by the Society to which he belongs, a composition fee for lectures. The amount of such composition fee shall be determined from time to time by the Board of Studies, but shall not exceed  $\pounds_2$  per Term.

6. Neither the Merton Professor of English Language and Literature nor the Professor of English Literature shall receive any remuneration out of the English Fund.

7. All sums received by the Board of Studies shall be paid into the University Chest to be carried to the credit of the Fund.

8. The accounts of the Board of Studies shall be audited annually by the University Auditor.

9. It shall be the duty of the Board of Studies to prepare and lay before Convocation annually a printed report on the administration of the Fund."

2. In Statt. Tit. XVII. Sect. IX. § 4 (p. 362), after cl. 3 the following new clause shall be inserted :—

"4. It shall be the duty of the Assistant Registrar to receive all fees due to the English Fund, to pay them to the Curators of the Chest, and to notify to the Curators the amounts payable out of the Fund under the authority of the Board of Studies for the Examination in the Final Honour School of English Language and Literature."

(2)

WHEREAS it is expedient to prescribe by Statute the conditions under which a person resident abroad may supplicate in absence for the Degree of Bachelor of Arts, Bachelor of Letters, or Bachelor of Science, THE UNIVERSITY ENACTS AS FOLLOWS.

In Statt. Tit. IX. Sect. V (p. 291, ed. 1909), before cl. 1 the following new clause shall be inserted :---

"I. It shall be lawful to confer the Degree of Bachelor of Arts, Bachelor of Letters, or Bachelor of Science upon a person who is not present to receive the degree, subject to the following conditions :---

(a) He must be resident abroad.

(b) He must obtain the grace of his College or Hall, or if a Non-Collegiate Student of the Delegacy of Non-Collegiate

Students, and he must have satisfied all other statutory conditions precedent to the degree for which he desires to supplicate.

(c) He must apply, through the Society to which he belongs, to the Hebdomadal Council for leave to supplicate in absence, and must satisfy the Hebdomadal Council (i) that he has not had a reasonable opportunity of taking the degree in person, (ii) that the taking of the degree is a matter of urgent importance to him.

(d) The application must be made not more than six calendar months after the degree day next following the day on which he became qualified to supplicate for the degree.

(e) The Society shall at the same time notify the Proctors of the application.

(f) If Council approves the application, its approval shall be forthwith published in the usual manner.

(g) He shall be at liberty to supplicate for the degree on any degree day being not less than seven days nor more than two calendar months after the day on which the approval of Council has been published as aforesaid."

#### 4. Decree.

The following form of Decree was proposed :--

That provided the University dues which have accrued during the period in which his name has been absent from the books of the University be accounted for, HERBERT JENNINGS ROSE, Fellow of Exeter College, who was admitted to the degree of M.A. on April 28, 1910, be deemed to have duly incepted in the Faculty of Arts on that day.

[Carried: nemine contradicente.]

## IV. CONGREGATION OF THE UNIVERSITY.

The form of Statute establishing a Delegacy for the supervision of Women Students, and transferring to this Delegacy the duties imposed upon the Delegates of Local Examinations under the provisions of Statt. Tit. VIII. Sect. 1. § 3, was promulgated and the Preamble thereof approved on a division (*placets* 159, *non-placets* 28).

## 2. Promulgation of Statute.

The form of Statute amending certain parts of the Statutes (1) by striking out clauses which have become obsolete, (2) by amending or striking out clauses which are in apparent conflict with other clauses, was promulgated and the Preamble thereof approved (*nemine contradicente*).

## 3. Promulgation of Statute.

The form of Statute providing that the elected members of the Committee for nominating Examiners in the Theory, History, and Practice of Education should be chosen by the Delegates for the Training of Secondary Teachers was promulgated and the Preamble thereof approved (*nemine contradicente*).

WHEREAS it is expedient that candidates seeking Honours in Mathematics in the First Public Examination who have not been placed by the Moderators in one of the three Classes should (1) be no longer compelled, in order to satisfy the Moderators, to satisfy them in certain specified subjects; (2) be deemed, if they have satisfied the Moderators, and if they have also satisfied the Examiners in the Preliminary Examination in the School of Natural Science in any one of the subjects of that Examination except Subject 1: Mathematics, to have passed the said Preliminary Examination, THE UNIVERSITY ENACTS AS FOLLOWS.

1. In Statt. Tit. VI. Sect. 1. cl. 3 (p. 140, ed. 1909), in sub-clauses  $(a \ 1)$  and  $(a \ 3)$ , the words "in the subjects hereinafter prescribed" shall in each case be struck out.

2. Ibid., Sect. I. C. § 6. cl. 3 (p. 157), after the words "preceding clause" the following words shall be inserted:

"or if he shall have satisfied them in any one of the said Subjects other than Subject (1), Mathematics, and shall also have satisfied, in accordance with the provisions of Statt. Tit. VI. Sect. 1. D. § 3. cl. 14, the Moderators appointed to examine those who seek Honours in Mathematics in the First Public Examination."

3. Ibid., § 11. cl. 4 (d) (p. 165) and § 12. cl. 6 (e) (p. 168), the words "in the subjects hereinafter prescribed" shall in each case be struck out.

4. Ibid., Sect. I. D. § 3. cl. 14 (p. 174), the words "in Algebra, Trigonometry, Pure and Analytical Geometry, and Mechanics" shall be struck out.

WHEREAS it is expedient that Affiliated, Colonial, Indian, and Foreign Junior Students shall not be admitted to examination in the Final Honour School of English Language and Literature unless they have either obtained Honours in some other Final Honour School or passed the First Public Examination, THE UNIVERSITY ENACTS AS FOLLOWS.

In Statt. Tit. VI. Sect. I. C. § 11. cl. 4 (p. 165, ed. 1909), sub-clause (d) shall be struck out.

*Note.*—If the above form of Statute be approved by Convocation, the following form of Decree will be proposed :—

That the three Statutes relating to Affiliated, Colonial, Indian, and Foreign Students, which were approved by Convocation on February 22, May 3, and
